HISTORY

Co.As.It Italian Association of Assistance was established in NSW in 1968 under the auspice of the Italian Government. The initial aim of the voluntary organisation was to assist the large numbers of Italian migrants after the 2nd World War. The organisation is a registered charity and incorporated under the Corporations Act. Co.As.It NSW has become the most active and major ethnic voluntary agency in Australia, offering community services that range from Italian language classes and the Italian Bilingual School to aged care packages, drug and alcohol care and mental health programs.

The Board has many plans for the organisation, with the development of more income streams and a goal to further reduce the reliance on government grants bringing them down to below 60% of total income.

The Italian Bilingual School and aged care packages are seen as the big growth areas for the next 10 years.
